flood damaged homes Before children return, schools and outdoor play areas should be cleaned and ready for use Children and, whenever possible, teens should not be involved in cleanup efforts but should return after the area is cleaned up In short, children should be the last group to return to areas impacted by flooding and/or hurricanes
